The City of Hollywood Police Department's Vice, Intelligence and Narcotics Unit has arrested five individuals in connection with the sale of illegal narcotics and stolen firearms. On Thursday, October 26, 2017, the Special Weapons and Tactics (SWAT) Team assisted the Vice, Intelligence, and Narcotics Unit with the execution of a Narcotics Search Warrant at 2735 Pierce Street, Apartments 7A and 1B, Hollywood, Florida.

The four-month undercover operation resulted in five arrests and the seizure of Cocaine (20 grams), Cannabis (398.8 grams), and varying amounts of prescription pills. Detectives also recovered a stolen handgun.

During the course of the investigation, detectives developed information that an individual by the street name of "Chico" was selling Crack Cocaine from 2735 Pierce Street, #7A. "Chico" was identified as Jecksan Antonio Vega.

Arrestee Jecksan Vega faces charges of Grand Theft of a Firearm and Two (2) counts of Delivery of Cocaine 1000ft of a School. Arrestee Heather Salogga faces one (1) count of Delivery of Cocaine 1000ft of a School. Arrestee Avenack Etienne faces one (1) count of Delivery of Cocaine 1000ft of a School. Arrestee Richard Joseph faces one (1) of Trafficking Oxycodone, and Arrestee Davante Houston faces one (1) of Trafficking Oxycodone, two (2) counts of Delivery of Cocaine 1000ft of a School, and two (2) counts Delivery of Oxycodone 1000ft of a School.
