

RESOLUTION NO. R-2021-155

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING THE ONE YEAR ACTION PLAN FOR FEDERAL FISCAL YEAR 2019-2020 TO ALLOCATE \$1,125,498.00 OF THIRD ROUND COMMUNITY DEVELOPMENT BLOCK GRANT COVID-19 FUNDS; AMENDING THE FISCAL YEAR 2021 OPERATING BUDGET; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS TO FACILITATE THE AMENDMENTS.

WHEREAS, pursuant to the authority provided under the Coronavirus Aid, Relief and Economic Security (“CARES”) Act, the United States Department of Housing and Urban Development has allocated a third supplemental Community Development Block Grant allocation (CDBG-CV3) with specific waivers to respond to the COVID-19 health emergency; and

WHEREAS, the City has received an appropriation of CDBG-CV3 funding in the amount of \$1,125,498.00 that may be allocated for program use; and

WHEREAS, staff recommends allocating the CDBG-CV3 funds to the following programs:

WHEREAS, proper notice has been provided to the residents of Hollywood prior to this hearing in accordance with the COVID-19 waiver set forth in 24 CFR Section 91.105(c)(2) and (k), Section 91.115(c)(2) and (i), and Section 91.401 to provide reasonable notice and opportunity for citizens to comment on substantial amendments; and

WHEREAS, on June 9, 2021, the Community Development Advisory Board met to review and evaluate the proposed Amendment to the One Year Action Plan along with the potential use activities eligible for funding for Fiscal Year 2019-2020, and have forwarded a recommendation of approval to the City Commission; and

WHEREAS, this Resolution seeks to amend the budget as detailed in the attached “Exhibit 1”, which allocates CDBG-CV3 funding within the Special Revenue Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes and approves amending the One Year Action Plans for Federal Program Years 2019-2020, as set forth in the attached Exhibit “1”.

Section 3: That it certifies that the City will comply with all applicable federal laws, regulations, policies, guidelines and requirements with respect to CDBG-CV3, including all assurances and certifications.

Section 4: That the City Manager or designee is authorized to execute the Substantial Amendment One Year Action Plan for Federal Program Years 2020-2021 submission, all necessary certifications, and is designated to be the authorized representative of the City to act in connection with the Substantial Amendment to the One Year Action Plan for Federal Program Year 2019-2020 and to provide any additional information as may be required.

Section 5: The City Manager or designee is further authorized and directed to assume the status of the responsible federal official of the National Environmental Policy Act insofar as the provisions of this act apply to this application.

Section 6: That the City Manager or designee is authorized and directed to consent, on behalf of the City and himself, to accept jurisdiction of the federal courts for the purpose of enforcement of his responsibilities as a designated federal official.

Section 7: That these Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2020, relating to the Special Revenue Fund and set forth in detail in the attached Exhibit “1” are adopted and authorized as Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year 2021.

Section 8: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
