3. **Presentation** - Presentation By Cameron D. Benson, City Manager, Regarding The Community Redevelopment Agency.

**ACTION:** Motion was made by Vice Mayor Blattner to call the question. The motion was seconded by Commissioner O'Sheehan and on voice vote failed 3-4. Commissioner Asseff, Commissioner Furr, Commissioner Russo and Commissioner Sherwood were opposed.

**ACTION:** Motion was made by Commissioner Furr to continue the discussion and any possible action until after the Commission and CRA Board meet at a workshop to be scheduled on or before May 20, 2008. The motion was seconded by Commissioner Asseff and on voice vote passed 4-3. Commissioner O'Sheehan, Vice Mayor Blattner and Mayor Bober were opposed.
