Explanation:	<p>The attached Resolution seeks City Commission authorization for the appropriate City Officials to apply for and if awarded accept Edward Byrne Memorial State and Local Law Enforcement Assistance Grant Funds in an amount not to exceed \$61,042.00 from the Florida Department of Law Enforcement for behavioral and substance abuse counseling and other related services provided by Broward Outreach Center for women involved in substance abuse and prostitution related activity. This Resolution also seeks authorization to execute all applicable Grant documents and Agreements as well as the expenditure of Law Enforcement Forfeiture Funds as matching funds required by this Grant. If awarded, \$20,348.00 of Law Enforcement Forfeiture Funds will be used as matching funds. A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND IF AWARDED ACCEPT EDWARD BYRNE MEMORIAL STATE AND LOCAL LAW ENFORCEMENT ASSISTANCE GRANT FUNDS IN AN AMOUNT NOT TO EXCEED \$61,042.00 FROM THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT FOR BEHAVIORAL AND SUBSTANCE ABUSE COUNSELING AND OTHER RELATED SERVICES PROVIDED BY BROWARD OUTREACH CENTER FOR WOMEN INVOLVED IN SUBSTANCE ABUSE AND PROSTITUTION RELATED ACTIVITY; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE GRANT DOCUMENTS AND AGREEMENTS; FURTHER AUTHORIZING THE EXPENDITURE OF LAW ENFORCEMENT FORFEITURE FUNDS AS MATCHING FUNDS FOR THIS PURPOSE IN AN AMOUNT NOT TO EXCEED \$20,348.00.

WHEREAS, the City's Police Department has requested authorization to apply for, and if awarded, accept Edward Byrne Memorial State and Local Law Enforcement Assistance Grant Funds in an amount not to exceed \$61,042.00 from the Florida Department of Law Enforcement for behavioral and substance abuse counseling and other related services provided by Broward Outreach Center for women involved in substance abuse and prostitution related activity; and

WHEREAS, the Broward Outreach Center has the resources and capability to provide behavioral and substance abuse counseling and other related services to women involved in substance abuse and prostitution related activity; and

WHEREAS, the Edward Byrne Memorial State and Local Law Enforcement Assistance Grant requires matching funds in the amount of \$20,348.00, which will be allocated from the Police Department's Law Enforcement Forfeiture Fund; and

WHEREAS, the Chief of Police recommends that the City Commission authorize the appropriate City Officials to apply for and if awarded accept Edward Byrne Memorial State and Local Law Enforcement Assistance Grant Funds in an amount not to exceed \$61,042.00 from the Florida Department of Law Enforcement for behavioral and substance abuse counseling and other related services provided by Broward Outreach Center for women involved in substance abuse and prostitution related activity; authorizing

the appropriate City Officials to execute all applicable Grant documents and Agreements; further authorizing the expenditure of Law Enforcement Forfeiture Funds as matching funds for this purpose in an amount not to exceed \$20,348.00;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the appropriate City Officials to apply for and if awarded, accept Edward Byrne Memorial State and Local Law Enforcement Assistance Grant Funds in an amount not to exceed \$61,042.00 from the Florida Department of Law Enforcement.

Section 2: That it hereby approves and authorizes the appropriate City Officials to execute any and all Grant documents and Agreements upon receiving said Grant Award.

Section 3: That it hereby approves and authorizes the expenditure of Law Enforcement Forfeiture Funds as matching funds in an amount not to exceed \$20,348.00.

Section 4: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
