PERFORMANCE JAR TESTING:

In order to determine proper dosage levels, performance testing shall be conducted. The vendor shall furnish all necessary supervision, chemicals, and special equipment necessary to conduct and monitor a complete and accurate performance test. The City will furnish personnel to assist the vendor during the testing period. The City will also furnish all power and dispose of sample. All testing shall be performed in the presence of the City's representative.

Vendor shall be responsible for establishing an appointment for this testing by calling the Wastewater Plant Manager, Coy Mathis or designee, Steve Farrell at 954-921-3288.

Each vendor will be permitted to conduct testing during an eight (8) hour shift beginning no earlier than 8:00 A.M. and ending no later than 4:00 P.M. the following time period:
