**COMMUNITY DEVELOPMENT BLOCK GRANT
HOME INVESTMENT PARTNERSHIP PROGRAM**

Pursuant to the authority provided under the Coronavirus Aid, Relief and Economic Security (“CARES”) Act, the United States Department of Housing and Urban Development (HUD) has published specific waivers for federal funding sources and allocated a supplemental of Community Development Block Grant funding with specific waivers to the respond to the COVID-19 health emergency (CDBG-CV). By memorandum of the HUD Assistant Secretary of Community Planning and Development, HUD waives the 30-day minimum for the required public comment period for substantial amendments, provided that no less than 5 days are provided for public comments on each substantial amendment. The waiver is available through the end of the City’s 2020 program year. The Citizen Participation Plan is being amended to be consistent with the 5-day minimum for the required public comment period.

Resolution No. 2020-167: Adopted on July 1, 2020 approved \$1,256,701.00 in anticipated CDBG funds and \$543,715.00 in anticipated HOME funds. The corrected allocation of \$1,256,510 in CDBG funds and \$543,611 in HOME funds to be allocated as follows:
